MANAGEMENT REPORT ON AGORA DOLLAR AND RESERVE ASSETS

Agora Blue Ltd (the “Company”) is responsible for the completeness, accuracy, and validity of the Management Report on Agora Dollar (“AUSD”) and Reserve Assets as of February 28, 2025 (hereafter the “Report Date”). The management of the Company asserts that the Fair Value of Reserve Assets is greater than or equal to the supply of AUSD in circulation and hereby makes the following assertions as of:

The Fair Value of Reserve Assets is defined as the total balance of U.S. dollar-denominated assets held as of the Report Date in the Agora Reserve Fund and in segregated accounts maintained by regulated financial institutions on behalf of AUSD holders. The Company’s Total Fair Value of Reserve Assets, which are greater than or equal to the supply of AUSD, are comprised of the following:

The Company maintains designated wallets on the Sui network, the Injective network, the Polygon network, and the Solana network specifically for holding AUDS that has been created but not yet in circulation. These are excluded from the total AUDS in circulation as detailed in this report. The created AUDS that is not yet in circulation, while custodied solely by the Company, are not backed by Reserve Assets until they are purchased and moved into circulation. The sole purpose of these wallets is to securely store this AUDS and facilitate their distribution on the blockchain upon purchase. The amount of AUDS in and out of circulation, the total AUDS supply, and the wallet address holding the AUDS out of circulation on each network is as follows:
